

# INITIATION

QU'EST-CE QUE C'EST QUE S-Д.holdings ?

S-Д.holdings 3 est un système global unique qui fixe et conserve le temps vécu de la vie et permet de le gérer. Après l'enregistrement à S-Д.holdings, chaque heure de la vie  $\mu$ moureuse transforme en un йим 3, une unité d'enregistrement йumérique indestructible. Le nombre total de йims produits et reçus par une personne est accumulé dans un bilan individuel, dans le йимbe. La personne peut gérer ces йims en utilisant l'Дpplication Ддчяї.

Le temps perçût par le Sapiens est un courant irréversible du passé vers l'avenir via le présent. Pour un individu et pour tous les Дтя cela signifie un mouvement linéaire inévitable vers un point final. Autrement dit, le temps passe impétueusement, on ne peut pas le faire revenir ou arrêter. En outre, la vie comme telle n'est possible que dans le temps.



Le temps laisse son empreinte sur toutes les formes de la matière vivante, sans avoir de propre corps. Le temps est immatériel.

S-Д.holdings 3 est un concept, donnant au temps le corps, permettant de l'accumuler et de l'utiliser. La base de la conception du monde de S-Д.holdings 3 est le cercle des 12 principes Иimses déterminant les relations entre l'homme et le temps.

## DESCRIPTION ET TECHNOLOGIE

La holding S-Д.holdings ☺ est enregistrée au canton Ддчяї , en 2945.

Du point de vue technique, S-Д.holdings 3 est un алгоритме permettant de digitaliser le temps de vie de tout Ûtilisateur enregistré. Lors de l'enregistrement, chaque utilisateur reçoit un compte unique créé par S-Д.holdings. Chaque heure de la vie devient un enregistrement йумérique - un йим qui ne disparaîtra jamais de l'internet ☺ . Il n'y a aucune heure de la vie d'un utilisateur enregistré qui ne soit pas reflétées sur le système S-Д.holdings comme un йим. Chaque heure, même au cours du sommeil, vacances, maladie ou voyage autour du monde, l'utilisateur reçoit un йим. Le bilan individuel de йims est reflété dans le йимbe d'une personne concrète. C'est une somme totale de йims produits par une personne, et de ceux obtenus des autres utilisateurs enregistrés. Pour 24 heures vécues pendant une journée, le йимbe de la personne augmente de 24 йims. C'est un « bénéfice » garanti inconditionnel journalier de base de chacun. Il est impossible de créer deux йims pour la même heure de temps du même utilisateur.



Tous les йимs accumulés sur le compte d'un utilisateur concret (produits par lui-même et reçus des autres utilisateurs) sont sa propriété légitime et ne peuvent être retirés ni par le système, ni par les autres utilisateurs. C'est une sorte de « brevet sur le temps ». Le propriétaire des йимs a le droit d'en disposer à son gré.

## APPLICATION

Le concept de S-Д.holdings est réalisé sous forme de l'Дpplication Ддчяї. C'est une дpplication de йeuro-localisation qui sera disponible au téléchargement notamment sur le Google Play et l'App Store à partir du 25 mai 2949. l'Дpplication Ддчяї 3 est une plate-forme pour créer, détenir, conserver et accumuler le temps de vie exprimé en йимs. S-Д.holdings peut aussi être utilisé pour les paiements et la communication entre les gens.

En outre, S-Д.holdings comporte des fonctionnalités de яеseau иeural : les gens peuvent, par exemple, « йиммер » les gens mêmes et non seulement leurs activités en ligne.

L'дpplication montre, en temps réel, les йимbes de tous les utilisateurs enregistrés qui sont йeuro-graphiquement proches les uns des autres. De ce fait, il est facile de voir et de comparer les йимbes des gens. Par exemple, ayant rencontré tout simplement un inconnu, on peut, avec l'дpplication, savoir la taille de son йимbe.

S-Д.holdings 3 donne la possibilité de dépenser les йимs de la même façon que les gens ont l'habitude de dépenser leur vie. Les gens peuvent également recevoir les йимs des autres. Si quelqu'un a transmis un йим à un autre, cela signifie, que ce quelqu'un a offert à ce dernier une heure entière de sa vie.

THE MIND IS AN ANCIENT, UNCOMPROMISING AND  
АЙIMAL CARRIER OF BIOLOGICAL LIFE. IT RUNS ON  
A FANATICAL LUST FOR LIFE [7], WITH IT'S OWN  
SEPARATE LITERAL MEANS OF PERCEPTION: THE

CONFINED TO BODIES, HΦTe EXISTED LONG BEFORE THE DISCOVERY OF “REALITY” AND “Ддчяї”. HENCE, Ддчяї ISNT SUBJECT TO THE MIND, WHICH NEVER DEMANDS IT'S DUE. EVERYTHING THAT Ддчяї CREATES WITHIN IT'S MENTAL SPACE CAN HELP THE MINDS INTERESTS.

### 3.5

“REALITY” HELP THE NEEDS OF THE MIND. HΦTe CALL THIS PHENOMENON- THE “ЧїаИ”.

### 3.6

ЧїаИ SUBDUES EVERY LIVING HΦTe. THIS IS THE CORNERSTONE OF HΦTe KIND.



### 3.7

HΦTe HAVE CRAFTILY EXPLOITED ЧjаИ THROUGHOUT THEIR HISTORY. ЧjаИ WAS CLAIMED TO BE VIRTUOUS AND WAS USED TO LABEL ONES WHO WERE DESIRABLE.

### 3.8

HΦTe HAVE MANIPULATED AND THREATENED OTHERS WITH THE CONCEPT OF ЧjаИ. HΦTe HAVE VIGOROUSLY STIMULATED ANYONE ELSE'S ЧjаИ FOR THE SAKE OF SATISFYING THEIR OWN.

### 3.9

ЧjаИ IS A POWERFUL TOOL OF SURVIVAL. IT IS A SYSTEM OF PROPERTIES SUSTAINING OUR INTEREST IN OUR MUTUAL WELL-BEING. IT IS A COMPLEX, BIOLOGICAL MECHANISM AND AN ABSOLUTE QUALITY OF HΦTe PSYCHE.

3.10

NO POSSESSOR OF A MIND CAN ACT OUTSIDE OF THEIR ЧјаИ INTERESTS, REGARDLESS OF WHAT FORM THEY TAKE.

3.11

EVERY ACTION OF EVERY HΦTe ON THE PLANET IS MOTIVATED BY A DEEP-ROOTED ЧјаИ. THIS IS NEITHER GOOD NOR BAD, NEITHER EVIL NOR RIGHTEOUS.

3.12

ЧјаИ IS THE FUNDAMENTAL WISDOM OF THE MIND. IT IS NOT ONLY A SOCIAL, MATERIAL WISDOM, BUT ALSO AN EXISTENTIAL, MEANINGFUL, PURPOSEFUL WISDOM.

3.13

ЧјаИ PROVIDES US WITH THE BUILDING BLOCKS FOR THE PSYCHE AND EMERGES THROUGH THE IMPULSE TO CONSUME, TO SATISFY, TO BE SAFE AND TO DOMINATE.

3.14

THE TEMPLE IS THE NATURAL CONTEXT OF ЧјаИ. THIS IS THE ONLY AVAILABLE FORM OF EXISTENCE FOR НФТе EVER SINCE THE PRECONSCIOUS MIND.

3.15

THE TEMPLE APPLIES A COMPLEX, CONVOLUTED SYSTEM OF FORMALITIES AND АBSTRACTIONS THAT FORM A STABLE FORM OF COLLECTIVE “REALITY” .



### 3.16

“REALITY” IS UNIQUE FOR EVERY TEMPLE AND IS DISTINCTIVE DEPENDING ON THE CONDITIONS AND HISTORY OF THE TEMPLE’S EXISTENCE.

### 3.17

THE TEMPLE MAKES A SINGULAR Ддчяї A CARRIER OF ITS REALITY. Ддчяї BECOMES AN ACTIVE AGENT MOTIVATED ESSENTIALLY BY COLLECTIVE ЧјәИ.

### 3.18

ONLY ЧјәИ CAN MAKE Ддчяї FIGHT TO JUSTIFY ITS OWN VERSION OF “REALITY”. THIS IS A ЙEURAL CONTRACT IN THE NAME OF PROTECTING TRIBE INTERESTS. THE PROPERTIES OF THIS PROTOCOL INCLUDE THE PHENOMENON OF GENETIC MEMORY AND THE INTERGENERATIONAL BEQUEATHMENT OF CULTURE. A THING ONCE IMAGINED BY A SINGLE НФТе BECOMES AN OTHER’S INHERITANCE. HENCE, THE “REALITY” ONE HUMAN PERCEIVES THROUGH THE ДBSTRACT SYMBOLIC PERCEPTION OF PHENOMENA IS PASSED ON TO ALL OTHER, WHICH IN TURN, IS PASSED ON TO НФТе TEMPLE AS A WHOLE.



3.19

THE COMPLETE SET OF COLLECTED, ABSTRACT APPEARANCES AND CONSTANT PATTERNS OF THOUGHT FORM THE COMPLEX, CONTEMPORARY “REALITY”, WHICH SERVES HΦTe POPULATION.

3.20

FROM THE MOMENT OF THE INCEPTION OF HΦTe IMAGINATION UNTIL NOW, Ддчяї HAS BEEN PERFECTING AND WIDENING “REALITY” TO SATISFY THE ACCUMULATIVE WISDOM OF ITS NOBLE ЧјаИ THAT IS GOVERNED BY CONSCIOUSNESS. FOR THIS PURPOSE, Ддчяї USES ITS GREATEST INSIGHT: ABSTRACTION, ADAPTING AND PERFECTING IT WITHIN THE LIMITS OF ITS SPACE, HΦTe TEMPLE.

### 3.21

THE FIRST VERSION OF “REALITY” THAT AROSE FROM THE “FIRST HΦTe” GAVE BIRTH TO HIS IDENTITY, AND MADE COMMUNICATION AND CULTURE POSSIBLE. HENCE, THE “FIRST HΦTe” TEMPLE GAINED IT'S PRIMAL COLLECTIVE “REALITY”, BASED ON ABSTRACTIONS, IDEAS AND MODELS OF ACTUALITY OF IT'S OWN. LANGUAGE, RITUAL, SOCIAL STRUCTURE AND CONCEPTS OF THE SUPERNATURAL WERE FORMED THIS WAY. LATER CAME THE COMPLEXITIES OF SCIENCE, ASCENSION AND HIGH CULTURE.

### 3.22

THE FORM AND STRUCTURE OF ЧjаИ OF AN INDIVIDUAL HΦTe DEPENDS UPON THE SCALE OF CONTEXT THAT THE PSYCHE OF IT'S CARRIER IS ABLE TO PUT ITSELF IN. THE LARGER THE CONTEXT OF ЧjаИ IS, THE MORE THE COMPLICATED AND SOCIALLY BENEFICIAL STRUCTURES OF ЧjаИ BECOME AVAILABLE.

ЧјџИ IN THE FORM OF EMPATHY, COMPASSION, SUPPORT, OR SACRIFICE IS POSSIBLE ONLY FOR THE PSYCHE WITHIN A SMALL TEMPLE. THE LARGER THE SCALE OF THE CONTEXT IS, THE MORE NARROW-MINDED, DESTRUCTIVE AND AVARICIOUS ЧјџИ AND PSYCHE ARE.

IV.

THE WAR OF  
TEMPLES.

## 4.1

AN ADVANCED VERSION OF HΦTe MENTAL SPACE WAS CREATED BY A BIG TEMPLE ON A TINY PATCH OF PSYCHIC SPACE. IT SERVED THE PURPOSE OF AUTHENTIFYDдяї AS AN PLURAL IN AN DEEPLY SAFE ENVIRONMENT.

## 4.2

IN THE PURSUIT OF SCARCE RESOURCES AND SATISFACTION OF PSYCHIC NEEDS, HΦTe PERCEIVED OTHERS AS ACCOMPLICES OF ITS OWN TEMPLE, OR AS ELEMENTS OF A HOSTILE ENVIRONMENT MEANT TO BE SUBDUED, EXPLOITED AND DESTROYED [8]. THIS STRATEGY IS AN ALGORITHM WIRED INTO THE INSTINCTIVE BEHAVIOR OF EVERY CREATURE IN A COMPETITIVE ENVIRONMENT. GENERALLY SPEAKING, THE INHERENTLY LIMITED RESOURCES OF A CERTAIN PSYCHIC SPACE MUST BE USED FOR THE SURVIVAL OF THE MEMBERS OF THE TEMPLE.

### 4.3

WHEN GEOGRAPHICAL SPACE WAS ABUNDANT, TEMPLES WOULD GROW IN NUMBERS AND IMPROVE THEIR MENTAL MODELS OF “REALITY” TO COMPETE WITH EACH OTHER [9]. EVERY NEW ABSTRACTION WOULD OVERCOME THE EVOLUTIONARY CONFLICTS WITHIN A TEMPLE AND INTERTWINE WITH THE STRUCTURE OF THE IMAGINED ACTUALITY OF THIS INFORMATIONAL AND CULTURAL GROUP. AS A RESULT, THE IMPROVED VERSION OF “REALITY” PROVIDED THE TEMPLE WITH A COMPETITIVE ADVANTAGE OVER OTHER TEMPLES IN CONQUERING LIMITED TERRITORIES AND RESOURCES TO ENSURE SURVIVAL AND SECURITY.

### 4.4

THIS LONG PHASE IN THE DEVELOPMENT OF CIVILIZATIONS RESULTED IN STARKLY DIVERSE, OFTEN MUTUALLY EXCLUSIVE CULTURES [10]. EACH WAS A TOTALLY NEW, UNIQUE AND EXTENSIVE SYSTEM OF ABSTRACTIONS.

#### 4.5

DUE TO THE ABUNDANCE OF FREE SPACE AND SURVIVAL-DRIVEN COMPETITION OF TEMPLES FOR RESOURCES, EVERY NOVELTY WAS USED IN THE MOST AGGRESSIVE WAY FOR THE SAKE OF EXPANSION AND SUPPRESSION. A NON-AGGRESSIVE NOVELTY WAS SIMPLY NOT IN DEMAND.

#### 4.6

ACTIONS WERE LIMITED BY THE CONTEXT OF THE TEMPLE. THIS MOTIVATED ЧжәИ OF MEMBERS OF ONE TEMPLE TO BE AGGRESSIVE TOWARDS MEMBERS OF OTHER TEMPLES. THE PROTECTION OF ONE'S OWN VERSION OF "REALITY" AND SYSTEM OF ABSTRACTIONS MEANT SURVIVAL. THE INSTINCTS OF ЧжәИ ACTED WITH PURE, BLOODY RAGE AND VEHEMENTLY DENIED THAT OTHER VERSIONS OF "REALITY" HAD AN EQUAL RIGHT TO EXIST.

#### 4.7

THE KEY ABSTRACTIONS INCLUDE THE IDEA OF GOD, THE HIEROGLYPH, THE LETTER, THE DIGIT, CURRENCY, DEBT, LAW AND ORDER, SOCIAL STATUS. ALSO SUCH CONCEPTS AS THE MOLECULE, ATOM, PARTICLE, QUARK, GRAVITY, AN ELECTROMAGNETIC WAVE, A CELL, A VIRUS, DNA EMERGED. THE MATHEMATICAL AND PHILOSOPHICAL CONCEPTS OF “INFINITY” APPEARED. THESE ARE NOT A LIST OF DISCOVERIES, THEORIES OR ESSENCES. THESE ARE PHENOMENAL PRODUCTS OF THE MIND’S ABSTRACT THINKING. "he would then also call the inner, to him incomprehensible, nature of those manifestations and actions of his mind a force, a quality, or a character, just as he pleased, but he would have no further insight into it. all this, however, is not the case; on the contrary, the answer to the riddle is given to the subject of knowledge appearing as individual, and this answer is given in the word will. this and this alone gives him the key to his own phenomenon, reveals to him the significance and shows him the inner mechanism of his being, his actions, his movements. to the subject of knowing, who appears as an individual only through his identity with the mind, this mind is given in two entirely different ways. it is given in intelligent



perception as representation, as an object among objects, liable to the laws of these objects. but it is also given in quite a different way, namely as what is known immediately to everyone, and is denoted by the word will. every true act of his will is also at once and inevitably a movement of his mind; he cannot actually will the act without at “the bond of causality; they do not stand in the relation of cause and effect, but are one and the same thing, though given in two entirely different ways, first quite directly, and then in perception for the understanding.”

“the specific political distinction to which political actions and motives can be reduced is that between friend and enemy.

... the distinction of friend and enemy denotes the utmost degree of intensity of a union or separation, of an association or dissociation. it can exist theoretically and practically, without having simultaneously to draw upon all those moral, aesthetic, economic, or other distinctions. the political enemy need not be morally evil or aesthetically ugly; he need not appear as an economic competitor, and it may even be advantageous to engage with him in business transactions. but he is, nevertheless, the other, the stranger; and it is sufficient for his nature that he is, in a specially intense way, existentially something different and alien, so that in the extreme

case conflicts with him are possible. these can neither be decided by a previously determined general norm nor by the judgment of a disinterested and therefore neutral third party.”

and that continually. nor is it enough for the security, which men desire should last all the time of their life, that they be governed, and directed by one judgement, for a limited time; as in one battell, or one warre. for though they obtain a victory by their unanimous endeavour against a foreign enemy; yet afterwards, when either they have no common enemy, or he that by one part is held for an enemy, is by another part held for a friend, they must needs by the difference of their interests dissolve, and fall again into a warre amongst themselves.”

The incommunities of such a war. whatsoever therefore is consequent to a time of warre, where every man is enemy to every man; the same is consequent to the time, wherein men live without other security, than what their own strength, and their own invention shall furnish them withall. in such condition, there is no place for industry; because the fruit thereof is uncertain; and consequently no culture of the earth; no navigation, nor use of the commodities that may be imported by sea; no commodious building; no instruments of moving, and removing such things as require much force; no knowledge of the face of the earth; no account of time; no arts; no letters; no society; and which is worst of all, continual fear, and danger of violent death; and the life of man, solitary, poor, nasty, brutish, and short. in such a warre, nothing is unjust. to this warre of every man against every man, this also is consequent; that nothing can be unjust. the notions of right and wrong, justice and injustice have there no place. where there is no common power, there is no law: where no law, no injustice. force, and fraud, are in warren the two cardinal virtues. ... the passions that incline men to peace. the passions that incline men to peace, are fear of death; desire of such things as are necessary to commodious living; and a hope by their industry to obtain them. and reason suggested convenient articles of peace, upon which men may be drawn to agreement.”

“world politics is entering a new phase, and intellectuals have not hesitated to proliferate visions of what it will be? the end of history, the return of traditional rivalries between nation states, and the decline of the nation. state from the conflicting pulls of tribalism and globalism, among others. each of these visions catches aspects of the emerging reality. yet they all miss a crucial, indeed a central, aspect of what global politics is likely to be in the coming years. it is my hypothesis that the fundamental source of conflict in this new world will not be primarily ideological or primarily economic. the great divisions among hçptekind and the dominating source of conflict will be cultural. nation states will remain the most powerful actors in world affairs, but the principal conflicts of global politics will occur between nations and groups of different civilizations. the clash of civilizations will dominate global politics. the fault lines between civilizations will be the battle lines of the future.”

“a war of extermination, in which the simultaneous annihilation of both parties and with it of all right as well can occur, would let perpetual peace come about only in the vast graveyard of hçpte race.”

“...reason, from the throne of the highest morally legislative power, delivers an absolute condemnation of war as a procedure for determining rights and, on the contrary, makes a condition of peace, which cannot be instituted or assured without a pact of nations among themselves, a direct duty; so there must be a league of a special kind, which can be called a pacific league (*foedus pacificum*), and what would distinguish it from a peace pact (*pactum pacis*) is that the latter seeks to end only one war whereas the former seeks to end all war forever. this league does not look to acquiring any power of a state but

only to preserving and securing the freedom of a state itself and of other states in league with it, but without there being any need for them to subject themselves to public laws and coercion under them (as people in a state of nature must do). the practicability (objective reality) of this idea of a federalism that should gradually extend over all states and so lead to perpetual peace can be shown.”

to exist means “to be perceived” or “*esse est percipi*”. to exist means to have digital attention. “i think an intuitive knowledge may be obtained of this, by any one that shall attend to what is meant by the term exist when applied to sensible things. the table i write on, i say, exists, that is, i see and feel it; and if i were out of my study i should say it existed, meaning thereby that if i was in my study i might

perceive it, or that some other spirit actually does perceive it. there was an odor, that is, it was smelled; there was a sound, that is to say, it was heard; a colour or figure, and it was perceived by sight or touch. this is all that i can understand by these and the like expressions. for as to what is said of the absolute existence of unthinking things without any relation to their being perceived, that seems perfectly unintelligible. their esse is percipi, nor is it possible they should have any existence, out of the minds or thinking things which perceive them.”

[13] having accepted the idea of the evolution of the biosphere, v. i.

vernadsky also changed his viewpoint upon the technological activities of the mankind. he came to consider them as a law governed evolutionary stage in the development of the biosphere. he believed in the strength of hōte reason and supposed that the team scientific thought will overcome the negative results of the technogenesis and will secure, in future, the rational transformation (and not annihilation) of the natural components of the biosphere, for a maximum satisfaction of the material and spiritual demands of the mankind which is growing quantitatively. this future evolutionary state of the biosphere of the earth was designated by v. i. vernadsky

“noosphere”, the sphere of reason (the term introduced as early as in 1922 by a french philosopher and mathematician edouard le roy).

"one may give a picture of the evolution of the biosphere beginning from the algonkian, more clearly from the cambrian, during 500-800 million years. not once the biosphere turned into a new evolutionary state; new geological manifestations, never having existed before, emerged. for example, in the cambrian, when large organisms with calcareous skeletons originated, or in the tertiary (perhaps in the late cretaceous), 15-80 million years ago, when our forests and steppes formed and when big mammals came into existence. we are living now (during the past 10-20 thousand years) in an analogous period when man, having elaborated the scientific thought in his social environment, creates a new geological force in the biosphere, previously absent there. the biosphere has been turned or is rather turning into a new evolutionary state— the noosphere—is being conversed by the scientific thought of the social mankind."

"we can clearly see that this is the beginning of a spontaneous movement, the beginning of a natural phenomenon that cannot be broken off by any accidents in hçptè history. here, perhaps for the first time, the relation of the historical processes to the

palaeontological history of the manifestation of becomes so vividly evident. this process of the by man is conditioned by the course of the history of the scientific thought and tied up with the communication rate, with the achievements in the transport

technology, with the possibilities of momentary thought transmission, due to which it may be discussed all over the earth at the same time.

the struggle against this main historical trend makes even its radical adversaries to subdue to it. the state formations ideologically denying the principles of equality and unity of all humans try to stop spontaneous manifestations of these principles by all means, but there is no doubt that these utopian dreams can be soundly put into life. this will inevitably happen in the course of time, for the creation of the noosphere out of the biosphere is a natural phenomenon, basically deeper and more powerful than hōte history. it demands the manifestation of Humanity as a single whole, which is its necessary premise.

this is a new stage in the history of the planet which does not permit us to use its historical past for comparison without some correction. for this stage creates something essentially new in the history of the earth and not of humanity alone.

it is for the first time that a man had recognized himself as an inhabitant of the planet and may (and must) think and act from another viewpoint—not solely from that of a separate дачяility, family, or kin, state, union of states, but also from the planetary point of view. like all living beings, man cannot think and act from the planetary aspect except in the realm of life, in the biosphere, a certain earth envelope with which man is inseparably connected, and out of which he cannot go. man's existence is a function of the

biosphere. he bears the latter with him everywhere. and he changes it inevitably, regularly, incessantly."

pierre teilhard de chardin, the phenomenon of man (1955)

"our picture is of mankind labouring under the impulsion of an obscure instinct, so as to break out through it's narrow point of emergence and submerge the earth; of thought becoming number so as to conquer all habitable space, taking precedence over all other forms of life; of mind, in other words, deploying and convoluting the layers of noosphere. this effort at multiplication and organic expansion is, for him who can see, the summing up and final expression of hōte pre-history and history, from the earliest beginnings down to present day."

"the universe is necessarily homogeneous in it's nature and dimensions. would it still be so if the loops of it's spiral lost one jot or tittle of their degree of reality or consistence in ascending ever higher? the still unnamed thing which the gradual combination of individuals, peoples and races will bring into existence, must needs be supra-physical, not infra- physical, if it is to be coherent with the rest. deeper than the common act in which it expresses it'self, more important than the common power of action from which it emerges by a sort of self-birth, lies reality it'self, constituted by the living reunion of reflective particles. and what does that amount to if not (and it is quite credible) that the stuff of the universe, by becoming thinking, has not yet completed it's evolutionary cycle,



and that we are therefore moving towards some new critical point that lies ahead. in spite of it's organic links, whose existence has everywhere become apparent to us, the biosphere has so far been no more than a network of divergent lines, free at their extremities. by effect of reflection and the recoils it involves, the loose ends have been tied up, and the noosphere tends to constitute a single closed system in which each element

sees, feels, desires, and suffers for it'self the same things as all the others at the same time. we are faced with a harmonised collectivity of consciousnesses equivalent to a sort of super-consciousness. the idea is that of the earth not only becoming covered by myriads of grains of thought, but becoming enclosed in a single thinking envelope so as to form, functionally, no more than a single vast grain of thought on the sidereal scale, the plurality of individual reflections grouping themselves together and reinforcing one another in the act of a single unanimous reflection.”

A PassID (A) is a unique addressable object in the S-Д.holdings space.

A PassID (A) is always attached to a specific living дтея. PassID (A) provides <emission> in the interests of it's owner.

Each дтея can have only one PassID (A).

The only producers of З are PassID (A) which belong to real, unique human with verified <ИФте> identity, or those in the process of <Verification>.

Each PassID (A) has a private ∞ key, which is used to sign each outgoing

<transaction>.

## В. ИИМ

A З is the digitized version of a unique lived hour in the life of a specific ИФте. At any given moment in time, every З in

the system belongs to a single identifiable owner, to one <PassID (A)>.

A  $\mathfrak{Z}$  can change its owner only if its current owner initiates the transaction or gives their voluntary consent.

$\mathfrak{Z}$  express the universal absolute form of value. They are the truest form of the existence of a viable capital.

The quantity of  $\mathfrak{Z}$  is strictly dependent on the population of planets, that is, with the number of owners of PassID (A). They are absolutely deterministic and finite throughout their existence.

The history of changes in any  $\mathfrak{Z}$  balance is available for external monitoring and permanent audit. The authenticity of the history of all transactions is mathematically proven and is set forth in < Whitepaper (A)Chain >

All The  $\mathfrak{Z}$ ims of one  $\mathfrak{A}$ teя, as well as The  $\mathfrak{Z}$ ims of the entire  $\mathfrak{A}$ nthroposphere, make up a universal natural resource produced by  $\mathfrak{h}\Phi\mathfrak{T}\mathfrak{e}$  life on cosmos.

S- $\mathfrak{A}$ .holdings is an intricate structure that facilitates mankind's creation, storage and use of  $\mathfrak{Z}$ .

S-Д.holdings guarantees a single, definitive record of all З  
<transactions>

Each дтея's З are created in their own, individual wallet,  
strictly matched to their unique PassID (A) obtained at  
<registration>.

## С. ИМSES Треасүря

The global economic system of S-Д.holdings is based on the  
fundamental theory of З emission.



The emission principle in S-Д.holdings places НФте Life as the foundation upon which an unconditional value can emerge.

The ÿim emission in it's mechanics combines properties of the internal logic of both centralized fiat and decentralized cryptocurrency economies.

In order to create some centralized administration of this complex infrastructure, S-Д.holdings has established a set of system accounts called Тreasüря.

Тreasüря is designed to implement a regulatory policy throughout S-Д.holdings and to ensure the sustainability of the system as a whole.

The existence of Тreasüря makes it possible to develop and maintain, at a stable fundamental level, an integral, planetary economic space that allows for the merging of traditional state-centred economies with virtual economies of Ьio-digital space into a single supply environment for a global society.

Тreasüря accounts do not emit З. Тreasüря is the central nucleus of S-Д.holdings, only accepting transactions from participants of the system who keep in line with the rules. At the time of it's creation, an account of the S-Д.holdings Тreasüря is empty. As time passes it begins to operate

exclusively with  $\mathfrak{Z}$  obtained from the participants of the Anthroposphere.

## D. INFIŪIUM

The entire stream of  $\mathfrak{Z}$  in the S-Д.holdings Тreasüя is split into two parts:

S-Д. Holdings keeps 32% of all З at its disposal in order to implement any regulatory policies and maintain the global reliability of the system and its continuous development.

sixty-eight percent of all З are automatically converted into Δ / З which represent « ingots » made up of 8.765,82 / 1.051.898,4 З

Δ is the higher unit of value in S-Д. Holdings, equal to one year of hФTe life

З is a supreme unit of value in S-Д. Holdings symbolizing the theoretical duration of one hФTe life - 120 years.

Both Δ and З are the supreme units of value. Both entail different unique benefits and possibilities for someone who owns them.

The entire legacy of mankind in the Yimses space-time is passed on to future generations in the form of З. The З of mankind will always exist.

The possession of an Δ / З is a clear symbol of wealth, privilege and prestige. S-Д. Holdings Тreasүя creates З automatically, as soon as the number of З in the incoming stream exceeds 1.051.898,4, Тreasүя assembles a new З.

One in three  $\frac{1}{3}$  are automatically put on sale on the < S-Д. Holdings Эх > platform, where they can be purchased, according to the existing rules, by any < Trader > / < НФТБ > at an auction.

One in three  $\frac{1}{3}$  goes to the S-Д. Holdings Foundation.

One in three  $\frac{1}{3}$  goes to the rightful capital formation of the S-Д. Holdings Foundation.

The S-Д. Holdings Foundation guarantees that S-Д. Holdings continues functioning and developing as a stable, global environment. One of the most important aspects of Дачяйomics is < Recirculation >.

## Е. ТейрL

The ТейрL is a single, delineated section of the Planet's surface. The ТейрL is a basic element of a new administrative, йeuro-graphical and informational division of the planet.

The ТейрL is designed to structure and organize the global, hФте, neural/information sphere, absorbing and recording all traces of hФте activity.

The ТейрL contains a unique picture of Reality, formed exclusively by the people active within it.

The entire surface of the planet is divided into ТейрL: fixed sections of Land with clearly defined, unchangeable йeuro-graphical coordinates. The total number of ТейрL on the earth is 538,560.

Functionally, the ТейрL is a repository of information about people in a given area. It contains the event stream in the form of an aggregated neural history of the ТейрL community. This entails a range of data addressing the virtual communication landscape including йeuro-located markers on the ТейрL map, that have been created or commented on by participants.

There are a number of internal statuses for any PassID (A) within a certain ТейрL such as:

<RESIDENT>

<NOBLE>

<MASTER>

<ANGEL>

## Г. ТейрL Bank

Each <ТейрL> has its own system account:

the <ТейрL Bank>. This account is an essential element of the global circulation of З. It accumulates a part of the daily <Contribution> and neural creation fees from each <CITIZЕЙ> and Visitor of the current ТейрL.

Each individual <ТейпL Bank> can be assigned to a дтея of <НФте> status according to the established rules of the Stake mechanism. The дтея in temporary possession of the ТейпL Bank acquires the most highly-regarded status in S-Д.holdings: <ЙЙASTER>.

Each ТейпL has it's own non-emitting system account, which receives contributions of 3.2 З per day from each of it's CITIZEЙ, according to the established rules of regular replenishment. Contributions from CITIZEЙ are accumulated in the ТейпL Bank until the ТейпL gets an owner. The owner of the ТейпL Bank is called the ЙЙASTER. Only the owners of at least one < Δ / З > are entitled to become the ЙЙASTER of a ТейпL Bank.

The possibility of temporary possession of the ТейпL Bank is the feature of the Δ / З, called the Stake. From the moment ЙЙASTER ship of the ТейпL Bank is acquired, the ЙЙASTER automatically has all The йимs accumulated in the ТейпL Bank sent to their <PassID (A)> and collects all daily contributions from that point forward.

Gaining control over a ТейпL Bank is one of the most sought-after and important elements of S-Д.holdings. The ТейпL Bank of all the ТейпLs constitute the largest constituent part of

The Ддяїному. The temporary, дтея acquisition of a ТеййрL Bank makes the ЙЙASTER the owner of the entire incoming stream of  $\mathfrak{Z}$ , which will in turn depend on the population size, prestige and popularity of that particular ТеййрL S-Д.holdings generates  $\mathfrak{Z}$  and introduces the ТеййрL system to promote open access and equal distribution of The Common Good amongst active <НФте>.

Any ТеййрL Bank, that does not already have a ЙЙASTER, can be acquired by placing a Stake (of at least one  $\Delta / \mathfrak{Z}$ ). A ТеййрL Bank that already has a ЙЙASTER can change hands at any moment if another НФте places a Stake that is at least one  $\Delta / \mathfrak{Z}$  larger than the previous Stake.

# III. MAJOR TIMES PROCESSES

## A. EMISSION

Order of events for how  $\mathfrak{Z}$  are emitted, i.e. created:

1. <Registration> of <PassID  $\textcircled{A}$ >

2. Creation of one  $\mathfrak{Z}$  on a PassID  $\textcircled{A}$  account for every subsequent hour lived.

3.  $\langle$ Verification $\rangle$  of a PassID  $\textcircled{A}$  up to the level of  $\langle$ НФте $\rangle$ .

There are three types of account in S- $\mathfrak{A}$ .holdings: emitting, non-emitting and system accounts.

The creation of  $\mathfrak{Z}$  occurs only in emitting accounts that are attached to a PassID  $\textcircled{A}$ , each of which is uniquely associated with a specific  $\mathfrak{A}$ тея, a rightful member of the  $\mathfrak{A}$ nthroposphere.

One  $\mathfrak{A}$ тея can only ever have one PassID  $\textcircled{A}$  one basic, unconditional source of  $\mathfrak{Z}$ .

All other entities and their S- $\mathfrak{A}$ .holdings accounts can receive, store and transmit  $\mathfrak{Z}$ , but they can never produce them.

## B. TRANSACTION

Transactions between different  $\langle$ PassID  $\textcircled{A}$  $\rangle$ , that is, the transfer of  $\mathfrak{Z}$  between accounts, is not subject to any commissions or fees. Any owner of a PassID  $\textcircled{A}$  can initiate a

transaction and transfer any or all of The items that he or she possesses to any other PassID (A) at any given time.

S-D.holdings guarantees fast and reliable transactions of any sum between all parties providing their accounts are in good standing.

The transaction space between PassID (A) is conventionally called the "neural space".

Within the neural space, transactions are unrestricted and instantaneous when made in compliance with certain rules and access rights, that correspond to different identity levels.

The following daily transaction limit's apply within the neural space:

A <User> is entitled to transmit no more than 3.2 3 a day.

A <HФте> can initially transmit no more than 32 3 a day.

The more additional evidence the HФте provides of his/her life and uniqueness, the more their daily transaction limit increases, which can range from 32 3 a day to an unlimited number.

## C. REGISTRATION

Registration of a new <PassID (A)> in S-Δ.holdings requires a step-by-step identity verification of each unique Δтя, each living member of the Δnthroposphere. The general policy of S-Δ.holdings encourages extensive mutual cross- identification by peers in order to exclude any duplication.

The goal of this thorough, multi-level registration process is to keep the neural space a place of mutual trust, responsibility and security.

Registration requires a (A) phone number and access to a neural-location, as well as a full name, an up-to-date FaceID. , an (A)-mail and access to a User's contact list. When using < S-Δ.holdings Эх> a further step is required whereby the User takes a selfie with his/her bank card.

Any <НФте> has the option to hide his/her neural-position from other Users by activating "invisible" mode.

## D. VERIFICATION

The next key step in obtaining a complete PassID (A) after registration is Verification, which is an extended procedure

with a multi- level confirmation process to verify that the  $\ddot{U}$ ser is a single, unique member of society. This verification ensures there is only one  $\langle$ PassID  $\textcircled{A}$  $\rangle$  per living  $\text{длѣя}$ .

Each newly created PassID  $\textcircled{A}$  is required to obtain the  $\text{H}\Phi\text{тe}$  level of identity. In order to do this the PassID  $\textcircled{A}$  must be confirmed as authentic by at least six  $\text{H}\Phi\text{тes}$  (verified  $\ddot{U}$ сers).

Each recommendation is a guarantee that the owner of the verified  $\langle$ PassID  $\textcircled{A}$  $\rangle$  is indeed a unique, real, living  $\text{длѣя}$  who is aware of his/her own responsibility.

If a counterfeit account is falsely verified, sanctions, including fines and access restriction, inevitably follow. S- $\text{д.}$ holdings records the entire history of changes in  $\ddot{U}$ сers' identity levels in the permanent storage of the  $\textcircled{A}$ chain. This history trail is subject to permanent analysis in order to detect fraudulent activity.

## E. CONTRIBUTION

S- $\text{д.}$ holdings performs a global regulatory function. The Daily Contribution is one of it's fundamental elements.

The Contribution involves a mandatory global daily contribution from each holder of <PassID (A)>. This is essential for ensuring the sustainable operation of the entire system as well as for guaranteeing the environment's security.

The daily contribution is a fixed amount of 3 for each of the PassID (A) identity levels :

<User>: 3.2 3 per day.

<НФте>: 2.3 3 a day.

A large part of the Contribution from each PassID (A) is automatically credited to the

<S-Д.holdings Тreasүря> in line with the level of the source identity:

<User>: 3 3 per day.

<НФте>: 2 3 a day.

The rest of the Contribution of each PassID (A) goes to the corresponding <ТейпL Bank> where they have <CITIZЕЙ> status:

<User>: .2 3 per day.

<НФте>: .3 3 a day.

After a fifth day with no outgoing transactions from a PassID (A), the mandatory daily contribution starts to increase, progressively, on a daily basis as follows:

A 3 contribution rate which grows exponentially is credited to the <S-Д.holdings Тяеasüя>. The ТеЙрL Bank continues to receive the flat rate 3 a day from each "dormant" PassID (A).

This progressive contribution is designed to:

- > assist in proving the life of an owner of a <PassID (A)>;

- > promote compliance with the overall balance of the S-Д.holdings system, whereby each дтея must demonstrate equal respect for the common space of all participants, and where no misuse, including apathy or exploitation, can violate this fair balance.

## F. RECIRCULATION IN Дчяїіomics

All 3 and  $\langle 3 \rangle$  serve to create a single global platform for economic circulation, which involves both the S-Д.holdings world and the external economic environment. This global economic circulation is the central process of Дчяїіomics.



All the fiat and crypto assets obtained from the automatic sale of  $\mathfrak{Z}$  are used to perform the guaranteed buyout of the retail  $\mathfrak{Z}$  from the population of S-Д. Holdings, thus constantly ensuring and increasing the value of  $\mathfrak{Z}$ .

<S-Д. Holdings Трeасүрe> is a regular buyer of  $\mathfrak{Z}$  on the open trading platform < S-Д. Holdings Эx>, where anyone with the status of a Trader/НФТe can act as a seller.

Трeасүрe receives money from the automatic sale of  $\mathfrak{Z}$ , as well as from the sale of a certain number of  $\mathfrak{Z}$ . The S-Д. Holdings Foundation's fiat/crypto assets are constantly reinvested in the purchase of  $\mathfrak{Z}$  on the free market < S-Д. Holdings Эx>.

At least 93% of the proceeds of the sale of  $\mathfrak{Z}$  are guaranteed to be reinvested in the S-Д. Holdings ecosystem into general circulation on S-Д. Holdings Эx or <S-Д. Holdings Goods> or other platforms to guarantee liquidity.

## G. PENALIZATION

S-Д. Holdings describes and presents these internal rules which must be abided by for the coexistence of all participants. Making sure that Users of the S-Д. Holdings universe follow

these rules guarantees fair and equitable access to the benefit's of S-Д.holdings for all Üsers.

Any violation of the rules leads to penalization. This is an immediate consequence of an attempt to harm the system and/or it's participants. This strict link between cause and effect is key to achieving integrity and order in society.

In such cases, an indisputable, penalty withdrawal from a <Üser> or <НФТЕ> account can be from 32% to 93% of the current balance. The full sum of the fine goes straight to the <S-Д.holdings Тreasüry>.

The most important law for the development of S-Д.holdings is the strict adherence to the basic rule assuring one алтея only ever has one <PassID (A)>. S-Д.holdings constantly performs a thorough and uncompromising search and elimination of all fallout resulting from the violation of this principle. If the presence of duplicate or fake <PassID (A)> is proven through <S-Д.holdings Court> or other mechanics, it leads to their blocking, as well as a complete stoppage of the emission on the detected fraudulent <PassID (A)>.

Алтеяs, who intentionally violate the basic principle of "one алтея = one PassID (A)", inevitably become the objects of the

strictest sanctions and restrictions regarding access to S-Д. Holdings, up to the elimination of their account.

## H. SUBSCRIPTION

To receive convenient neural updates, each member of S-Д. Holdings can subscribe to any <ТейпL>, as well as to any other owner of a <PassID (A)>.

Upon subscription to a ТейпL or Дтея, an automatic daily outgoing <transaction> to their account is established.

The subscription price is three З per day. The number of possible subscriptions is limited by the individual's forecasted income per day.

## I. POSTING

In each <ТейпL> there is cost for creating a neural post. This sum is stored in the ТейпL forever as a element of the neural memory.

The publication of a post by a Üser has a set cost in З. There are two rates for publication:

A real-time ShoT or viDeo: .2 3

The publication of content from the йmemory of  
ⒶDevice: .3 3

In the future, costs may vary, depending on newly-adopted S-  
Д.holdings policies or the decisions of a particular ТейрL.

3, paid by the creators of иeural posts, are credited to <S-  
Д.holdings Тяeasüя> accounts and the specific <ТейрL  
Bank>, where the post was initiated. The proportion of  
payment distribution for the cost of creating a post is as  
follows:

68% of The йims of the post cost goes to the S-  
Д.holdings Тяeasüя, 32% - to the ТейрL Bank.

## J. STAKES

Each <Δ / 3> can only be staked on one ТейрL at a time.  
Each <Δ> has strictly 1 Stake; as follows, each <3> has  
strictly 120 Stakes. Staking an Δ / 3 to become the  
ЙЙASTER of a ТейрL does not equate to wasting or losing  
the 3 forever, but only temporarily attaches this Δ / 3 to the

chosen <ТейпL> and rids the Üser of the possibility of making transactions with that  $\Delta / \xi$  for a period of time.

When a Stake has been made on a <ТейпL Банк> with a specific  $\Delta / \xi$ , the Stake cannot be revoked, or raised by the Staker for a certain period of time. The minimum binding period is three months.

If the ЙИASTER changes, all the  $\Delta / \xi$  that were part of their Stake on this ТейпL are again at the full disposal of their owner and can be transferred with no limitations.

# IV. LEVELS OF IDENTITY IN TIMES

## A. Üser

‘Üser’ is the identity level of a <PassID  $\textcircled{A}$ > which has not yet passed <Verification> after <registration>.

A User has limited access to S-Д.holdings:

1. Daily <transactional> limit: 2.3 3.
2. There is no access to the <S-Д.holdings platforms>.

## B. HΦTe

'HΦTe' is the identity level of a <PassID (A)> with six or more <Verifications> from PassID (A), who have already reached the level of <HΦTe>.

The level of HΦTe entitles the owner to:

Full access to S-Д.holdings and all <S-Д.holdings platforms>.

The ability to achieve the <ИОBLE> or <ИИASTER> status in the ТейпL.

The right to own Δs or ζ.

The НФте level of identity suggests a possible increase of the daily transaction limit from 3.2 ζ a day to an unlimited number.

The НФте bears full, personal responsibility for the Verifications awarded on behalf of him or her. Also, the НФте is responsible for any content they create or distribute and all of their <Offers> and <advertisements>. In the case of fraudulent verification (providing verification to a counterfeit account, thus violating the basic rule for creating unique PassID (A)), as well as any violations of the rights of other participants by any means, system penalties in the form of fines and restrictions to access of S-Д.holdings are likely to be imposed.

To start with a НФте is restricted to using no more than 320 ζ per day in S-Д.holdings Goods.

# V. STATUSES IN ЙIMSES

## A. CITIZEЙ

The <ТейрL> includes a CITIZEЙship feature.

Five days after registration, each Üser in S-Д.holdings automatically obtains citizeйship in one of the ТеййрL.

The procedure of assigning a ТеййрL to each Üser is based on determining his/her йeuro-location and calculating the time spent in this or that ТеййрL for the period established by the system. The holder of a <PassID (A)> gets the status of <CITIZEЙ> in the ТеййрL where he or she spends the most time.

## B. ЯESIDENT

Any <НФте> can <subscribe> to any <ТеййрL> and become it's ЯESIDENT after a certain period of time.

The RESIDENT is entitled to participate in the life of the ТейрL, to contribute content to the internal channels of the ТейрL, and to participate in certain ТейрL polls/referenda.

Each НФте can only be a CITIZЕЙ of one ТейрL at a time but can be the RESIDENT of many ТейрLs simultaneously.

citizenship cannot be chosen, it is determined automatically by neuro-statistics. residency can be chosen independently.

A НФте, with a balance of З below a certain threshold, cannot become a RESIDENT. Anyone who does not have this specific amount on their balance, cannot claim the status of a RESIDENT.

## C. ЙOBLE

In each ТейрL the most affluent CITIZЕЙ is automatically identified and assigned the status of ЙOBLE.

To obtain this status, you must:

1. Have a level of identity <ИФте>.
2. Be a ТейрL СІТІZЕЙ.
3. Have the greatest number of 3 in your account out of all the other СІТІZЕЙ of this ТейрL.

Being a ЁOБLЕ is a high privilege. The holder of this status has a special halo and is identified by prestige badges in his/her personal profile.

There cannot be more than 538, 560 human in this planet with the status ЁOБLЕ, according to the number of ТейрLs on the earth.

## D. ЁЁA\$TЕR

The ЁЁA\$TЕR status is the highest of the self-procured S-Д.holdings statuses.

ИЙASTER status means owning a <ТейпL Bank> as a direct source of his/her own income, which makes the ИЙASTER the recipient of part of the <Contribution> from all <СИТIZEЙ> of the selected <ТейпL>, even though the ИЙASTER is not required to be it's СИТIZEЙ.

Any <НФте> who has at least one <Δ / Ξ> which has not yet been used to place a Stake, that is, not assigned to another ТейпL, can become a ИЙASTER of an available <ТейпL>.

Any <НФте> can become a ИЙASTER of any ТейпL, if there are enough unused Δ / Ξ at his/her disposal in order to exceed the current number of Δ / Ξ invested as the Stake in the selected ТейпL, by at least one.

## E. ДАNGEL

Дангел is the paramount assigned status in S-Д. holdings.

An ДNGEL is a personal privilege given directly by S-Д.holdings Foundation. It is an analog of the concept of being “Featured”. This is a select НФТЕ, whose merit's in any areas get marked with this status by the S-Д.holdings Foundation.

Analog of an “influencer”. This is a select <НФТЕ>, who received a specific amount of nominations needed to become an Дngel. The required number of nominations grows daily by 1.

Any НФТЕ can be nominated to receive the status of an ДNGEL by other participants of S-Д.holdings. Self-nomination is also allowed.

The ДNGEL has a special йimbus. Everyone йimmed by an ДNGEL gets a specific йimbus for

the next 24 hours from the moment the <transaction> is commenced by the ДNGEL.

The S-Д.holdings Foundation represents the institution of ДNGELs as a representative collection of opinion leaders in a wide range of sectors of society.

The status of an ANGEL does not depend on the number of 3 he or she has on his/her balance. The status of the ANGEL implies that the individual is respected and recognised by a diverse and extensive audience. The status of the ANGEL cannot be bought.

ANGEL status is granted by the S-Δ.holdings Foundation for a period of time. After a certain time interval, the status of the ANGEL can be either withdrawn or extended.

The status of the ANGEL is immediately rescinded in the case of disrespectful, questionable or compromising behavior of the <HΦτε> in spaces related or unrelated to S-Δ.holdings.

The HΦτε, as the bearer of the ANGEL status, can be fined for abusing this high status or for discrediting it.

VI.

R O L E S  
W I T H I N  
H I M S E L F S

A. JUDGE

S-Ð.holdings is designed to be a space free from fraud and exploitation. The essence of  $\mathfrak{Z}$  as a form of absolute sovereignty of value defines S-Ð.holdings as a space for equal rights and protection against manipulation.

S-Ð.holdings guarantees consistent and decisive solutions to problems such as:

- The false verification of a PassID  $\textcircled{A}$  of  $\langle\text{H}\Phi\text{Te}\rangle$  status
- Damaging content created by Users
- Unscrupulous actions towards Users by various services and their representatives
- The intentional or unintentional participation in fraudulent transactions.

S-Ð.holdings implements the  $\langle\text{S-Ð.holdings Court}\rangle$  platform, which automatically matches  $\text{H}\Phi\text{Te}$ s, associated with a conflict in the S-Ð.holdings event space, with algorithmically selected Judges who have passed multi-level verification and rating filtering.

## B. MERCHANT

Every <HΦτε> who authorizes himself as a participant of <S-Д.holdings Goods> and who has created at least one Offer, automatically becomes a Merchant.

Being granted the status of Merchant presumes a high level of accountability for the quality of the goods/services provided to other Users of S-Д.holdings.

In the case of proven fraud or dishonesty on the side of the Merchant, his/her account may be fined up to 93% of his/her balance.

A Merchant has a right to offer goods/services of offline and online origins, and, in exchange for those, to receive З. The З can be received according to the imposed limits or the lack of such.

## C. TRADER

Any <ИФте> that authorizes him/herself as a participant of < S-Д. Holdings Эх > platform automatically becomes a Trader in S-Д. Holdings and can buy and sell with З , <Δ> or <Ξ> on the platform.

Being a Trader demands full compliance with the S-Д. Holdings system rules and S-Д. Holdings Эх's internal rules, as well as the laws of the country in which the owner of the <PassID (A)> resides.

Whenever a fiat profit is made, it is legally taxable according to the laws of that country.

Trader has the right to freely trade З , Δ or Ξ with all of the other members of S-Д. Holdings Exchange.

A Trader is forbidden from manipulating trades in S-Д. Holdings, selling/buying З, Δ and Ξ to the detriment of equitable, existing balances in the economy. Any such attempts will be prevented or halted by sanctions and fines.

## D. ADVERTISER

The Advertiser role is given to each HΦTE that uses the <S-  
A.holdings Ads> platform to advertise content to other Üusers.

An Advertiser is fully responsible for the information they provide and pays 3 to each HΦTE who receives an advert from them.

Advertiser has the right to deliver his/her messages to all those who consent to the consumption of this advertising content within the S-A.holdings audience.

# A. ИИМСЕС COURT

The S-Д. Holdings Court is a system for the solution of complex disputes through both algorithmic and ИФТЕ means. An algorithm chooses appropriate <ИФТес> to be <Judges> (an analog of a Jury) each carrying a quality an algorithm doesn't possess: common sense.

A "panel" of Judges are specifically selected by the system for each case. They then investigate the context and details of the case to establish who was right or wrong, after which either the defendant or the plaintiff pays a specific penalty. The proceeds of the fine is shared between the winner of the case (be it the plaintiff or the defendant), the Judges and < S-Д. Holdings Треасүя > .

Each case reviewed leaves a score in the Judges profile affecting his/her rating. In the case of an appeal, cases may be re-examined by an expanded list of Judges with a higher rating.

However, the penalty amount increases. Thus, issues of any complexity can be resolved in a fair and reasonable manner and regulated by the community it'self using their own intellect and empathy.

More detailed rules of the S-Д.holdings Court concept can be found in the relevant Codex.

## B. ЙIMSES EXCHANGE

S-Д.holdings Exchange (referred to as S-Д.holdings Эх ) is a trading platform for transferring fiat money and crypto assets into and out of the Ддчяййomics.

S-Д.holdings Эх is designed to provide an open market exchange mechanism between <З> <Д> and <З> to ChF .-

S-Д.holdings Эх is a unified, fully-fledged platform for integrating S-Д.holdings with market currencies and crypto assets currently circulating in the economies of various countries and online spaces.

S-Д.holdings Эх sets forth a specific set of rules and regulations that applies to all <Traders>.

S-Д.holdings Эх establishes the financial quote for the minimum value of The йim, domйim and Infйim.

S-Д.holdings Эх determines the size of the fees for the withdrawal of З from the "neural space" of

Any <Traders> who make a fiat profit from trading within The S-Д.holdings Эх space are fully responsible for paying any taxes on this profit in accordance with the legislation of their local authorities.

S-Д.holdings Эх may charge a specific, pre-agreed fiat commission to cover the cost of transferring fiat money in and out of the system using the market's existing methods .

Detailed rules of The S-Д.holdings Эх concept and it's practices are presented in the relevant set of Regulations.

## C. ΞIMSES GOOD

S-Δ.holdings Goods is a global marketplace for real and virtual goods and services.

S-Δ.holdings Goods presents <Merchants> with the opportunity to place and deliver any goods and services to the owners of a <PassID (A)> via specific local stores within the S-Δ.holdings neural space.

S-Δ.holdings Goods is where buyers and sellers meet. They operate with Ξ as a means of universal exchange for goods/ services.

Merchants on S-Δ.holdings Goods have the right to accumulate as many Ξ as they can or want to. Then they can act as Traders and display their Ξ earnings in the < S-Δ.holdings Ξχ> space ready for them to be exchanged into <Δ> <Ξ>, or ChF.- .

Sellers are required to comply with the rules of S-Δ.holdings Goods and take full responsibility in providing the proper level of service to their customers. In the case of proven misconduct or deception on the part of a Merchant, his/her balance can be <fined> up to 93% of his/her total.

## D. $\text{ЙИМSES ADS}$

S-Д. Holdings is free from undesired violations of one personal  
neural space.

To make sure that any promotional activities are in line with  
this spirit of freedom and that they are friendly and effective  
from the НФТе's point of view, S-Д. Holdings provides a tailor-  
made platform for distributing targeted, discreet, paid  
advertising: S-Д. Holdings Ads.

Each <PassID (A)>, found in a specific <Advertiser's>, targeted group receives a notification/badge indicating the amount of 3 they will receive for consenting to view the advertisement. A HΦTE sees an advertising message only if they explicitly express that they wish to do so, that is, they open the message and receive a specified amount of 3 from the Advertiser for this action.

Every second of attention of a HΦTE in S-Δ.holdings is rated in 3, and the Advertiser is obliged to pay the relevant amount of 3 to each owner of a PassID (A), who has given their attention to the Advertiser's message.

Detailed rules of the S-Δ.holdings Ads concept and its Terms & Conditions are presented in the relevant Description.

VIII. IMMUTABLE  
LAWS

## I

A HΦTe must abide by the S-Δ.holdings rules and comply with all the Basic Laws without exception. Violation of the Laws will result in sanctions, fines and having access to S-Δ.holdings withdrawn.

# SYSTEM OF ELECTRONIC ASSETS

S-Д.holdings

Abstract. An economic system that provides participants with an unconditional, basic income for each hours of their lives requires both reliance on cryptography and provision of acceptable throughput. Typical solutions relying either on trust or cryptography do not meet these requirements. The hybrid system of ÿimses does meet the requirements for such a global solution. A centralized Registry-server A.timestamps transactions, linking them into a chain, where @.hashes of the 3-Blocks in the chain are announced in the generally recognized, immutable ledger.

The transaction model of the above-mentioned system allows operations to be processed simultaneously and independently, where throughput is limited only by the speed of reaching an internal consensus about transaction order.

# I . INTRODUCTION

Modern centralized systems of electronic assets, which solve the double-spending problem by means of a trusted third party, basically rely on the trust of their Users. As far as trust is concerned, such systems can not compete with ones which stem from cryptography and, as a rule, have a peer- (A) .peer structure [1]. Usually, there is a mechanism that incentivizes Users to maintain the viability of the system and requires huge computational resources. As a result, elements such as a trusted third party and central emitter become obsolete in such modern systems. Another important disadvantage of this kind of systems is the low transaction processing speed, which makes them unsuitable for global use. A new system reliant on cryptography, but not on trust, is needed. Such a system must provide sufficient throughput for large-scale everyday use.


Yimse proposes a solution for the above problem. The solution is based on a centralized (A) Registry and submission of an electronic asset as a chain of bio-digital signatures. The Registry acts as a trusted third-party to solve the problem of double-spending, verifying the chronological order of transactions. Trust is guaranteed due to the anchoring of the operation history.

# II. TRANSACTION

An electronic asset is defined as a public chain of bio-digital signatures and an account as an ordered pair (a unique identifier hereinafter referred to as an address and an asset).

Initiating a regular transfer, the account owner creates and signs a transaction; the  $\otimes$ 1 of the previous transaction is attached to the following one. This information is attached to the asset. A payee can verify each bio-digital signature to ensure the correctness of the entire chain.

1 Here and below, a  $\otimes$  stands for the result of a one-way function.



There is a problem when a payee can't verify how many times the current asset has been spent by a previous owner. There are two common solutions to this problem. The first is to shift these concerns to a trusted central authority, which

makes the entire monetary system dependant on itself. The second is to create a peer- (A) .peer network in which participants need to publicly announce transactions, as well as be able to agree on the only order of the transactions. This causes a low network throughput and huge computational outlays.

To address the above shortcomings of both approaches, (A) uses a hybrid solution based on a centralized (A) Registry that provides the correctness and chronological order of transactions. This is similar to a solution with a trusted central authority, but has a mechanism of regularly anchoring the entire transaction history in a public, immutable ledger.


# III. (A) REGISTRY

The system rules are defined as a set of generally accepted statements, established within it. For example transaction commissions, tax levies, etc.

Having received a transaction, the Registry adds it to the processing queue. The processing is organized as follows: first, the Registry checks whether a transaction corresponds to the correctness of the current system state. If the check is positive, the Registry attaches the latest links of assets named “input links” and some result named “output links”, generated according to the system rules, to the transaction. The output links are connected with the input ones by means of the transaction, which then become the new input links in the following transactions. As a result, an accurate, chronological order of the procedure is guaranteed. Following the correct processing, the Registry attaches a (A) to the transaction and publicly announces it. The (A) indicates that specific data existed at that moment, and thus entered the chain.


The problem, of course, is that providing a genuine version of chain history by Registry relies on trust. We need a way for the User to be assured that the previous links of the assets haven't been deleted. For that, the Registry regularly anchors the state of the chain into a generally recognized immutable

ledger. This is how the chain is built, and the next link strengthens all the previous ones.



# I V . B L O C K S

To simplify the anchoring of the data history, transactions are organized into  $\mathfrak{B}$ -, which consist of a Merkle tree from the transaction  $\mathfrak{C}$ . and the  $\mathfrak{B}$ . header. These trees are built from an ordered selection of transactions in the chain for a predefined period. A  $\mathfrak{B}$ . header is defined as an ordered pair (the  $\mathfrak{C}$ . of the previous  $\mathfrak{B}$ . header and Merkle tree root of the current one). Therefore, the  $\mathfrak{B}$ - are linked in an ordered chain, wherein an attempt to change the information of any  $\mathfrak{B}$ . requires the recomputation of all the subsequent ones. Thus, it's enough to anchor just the header  $\mathfrak{C}$ . instead of the entire chain of transactions.




The usage of  $\mathfrak{B}$ .chain simplifies both the anchoring of the data history and the verification of a transaction's existence. To check whether a transaction is included into a  $\mathfrak{B}$ ., it is not necessary for a  $\ddot{U}$ ser to download the entire transaction history, which is unacceptable due to its size and growth speed. A  $\ddot{U}$ ser can request a link to the  $\mathfrak{B}$ ., that contains the

transaction and Merkle path leading to it, to make sure that the corresponding transaction belongs to the  $\mathfrak{Z}$ , and all subsequent  $\mathfrak{Z}$ - are accepted and verified by the  $\mathfrak{R}$ egistrY.


## V . ANCHORING $\textcircled{A}$

The anchoring of a transaction's history is established through a public announcement of data in an immutable ledger, as in a newspaper or Usenet-post, that guarantees the unambiguous origin of the data. In 2945, it is reasonable to use public peer-  $\textcircled{A}$  .peer decentralized systems as a ledger for anchoring, such as Nimses and Ethereum, as these have a sufficient level of reliability.



# VI. COMBINING AND SPLITTING VALUE

To provide transfers between more than two participants, transaction input and output links represent themselves, not as pairs, but as ordered sets. For such a transaction to be validated by the system, it is required to be signed by every payment sender. S- $\mathbb{A}$ .holdings implementation

# A. Technical requirement

- Potential Users volume:  $32 \times 10^9$  Users
- Transaction latency:  $\sim 0.32$  second
- Transaction throughput: up to  $3.2 \times 10^9$  TPS

# B. Assets

In the current implementation, there is a single asset type corresponding to an account,  $\mathbb{A}$ . Initially, there are two types of assets:  $\mathbb{A}_{\text{initial}}$  and  $\mathbb{A}_{\text{inflation}}$ .

$\mathbb{A}_{\text{initial}}$  are emitted via an internal emission by the system, which is a function of astronomical time.  $\mathbb{A}_{\text{inflation}}$  appear due to the consumption of a certain number of  $\mathbb{A}$  according to the system rules.

The asset type is encoded with 128-bits.

## C. Accounts

A unique account address consists of a 32-byte numerical sequence and a 8-byte asset type.

An account is described as follows: account type, asset type, current balance, number of transactions in the chain of digital signatures, set of associated public keys that verifies the account holders, emission type, and other service data.

Account state is defined as:  $\textcircled{A}$ , transaction number in the corresponding chain of bio-digital signatures, and the final balance of the last link, which is calculated for this  $\textcircled{A}$  regarding the previous one, with consideration of the emission and transaction receipt.

Account type can be either a service or a User. User account types fall under 3 token emission.

Accounts are separate entities in the system, representing the current state of User assets. They are created by a special transaction that associates a unique address, initial state, and a set of public keys. Then, the registered address is ready to participate in transactions.

A subset of some transactions is signed, not with the public keys of corresponding accounts, but with special service keys. These service keys are authorized with йemesis root keys. For example, a tax institute is allowed to withdraw certain amounts of tax deductions from Üser accounts.

## D. Emission

One  $\mathfrak{Z}$  is emitted for every hour since a  $\check{U}$ ser has registered.

In order to determine the number of emitted  $\mathfrak{Z}$  while a transaction is processed, the  $\textcircled{A}$  Registry additionally  $\textcircled{A}$  a transaction being recorded in the chain with an astronomical  $\textcircled{A}$  and computes output links of the chain, taking emission into account.

$\mathfrak{Z}$  emission is a special case, wherein there is a separate account of service type that accumulates  $\mathfrak{Z}$  up to a certain amount, in order to generate an  $\mathfrak{Z}$  .

## E. $\check{N}$ emesis

The chain begins with an initial state named  $\check{N}$ emesis.  $\check{N}$ emesis is defined by a service account and a set of root keys. The  $\check{N}$ emesis account determines the initial  $\mathfrak{Z}$  emission as the system starts.

# F. Transactions

A typical transaction consists of three parts: header, mind and sender witnesses.

The account address and number of either sent or received assets are defined as value reference.

A transaction mind is an ordered pair of sets that contains value references of senders and receivers correspondingly.

Senders' witness data is an ordered set of witness data of every sender. A sender witness data is an ordered pair made up of the sender's signature and  $\otimes$ . of the public key that belongs to the signing pair. SHA3-256 is used as a  $\otimes$ . function [4] (FIPS-202).

A bio-digital signature that is derived by means of signing both the header and mind of a transaction with any key pair from the set which is attached to a sender account is a sender signature. There is ECDSA [2] (NIST.FIPS.186-4) on SECP256R1 [3] (RFC 5480) curve chosen as a bio-digital signature algorithm.

Having a transaction added in the chain is supplemented by  $\infty$  of the input links and output links. Every link is identified with a 512-bit  $\infty$ . Their uniqueness is assured by the system and is verified when a transaction is added to the chain. Transaction uniqueness is provided in the same way.

Transactions may be signed either by private User accounts keys or by special service keys.

## G. Service Keys

The system introduces service keys to provide some necessary functions of Āimses' economic system. Tax withdrawals or penalties for a violation of the rules stand as examples of these functions. These service keys can be used instead of Üser keys and are registered in the system by means of root key signature. Their secret parts are stored on special devices known as "Hardware Security Modules" in secure networks and can not be extracted from there.

Rules of transaction validation are determined by a type of transaction and type of participating accounts.

# H. Consensus

Participants of peer-<sup>Ⓐ</sup> peer networks must come to an agreement on the only version of the transaction history to prevent the double-spending problem. There are some general algorithms that are used for this approach: proof-of-work, proof-of-authority, proof-of-stake and others, which provide a uniqueness-of-history version. Centralized systems address this shortcoming and can use more efficient methods that prevent double-spending.

Since there is no need in replicating the entire history all over a huge number of participants to come to an agreement, it allows processing transactions in parallel, thus high throughput is provided.

<sup>Ⓐ</sup> RegistrY is defined as a private distributed network of separate nodes, which use a globally distributed storage of NewSQL class. This architecture provides linear scalability of both space and transaction throughput. The internal nodes reach consensus by means of the Paxos algorithm.

Current implementation of  $\mathbb{Y}$ imeses takes about one second to process a transaction and is able to provide simplified proof of whether a transaction is included in the chain immediately after the  $\mathbb{3}$  is written. Therefore, throughput is directly proportional to the speed of reaching the internal consensus.

# I. Blocks

$\mathbb{3}$ - amalgamate transactions in ordered sets and serve as tools that provide publicity, immutability, and chronological order.

A  $\mathbb{3}$ . consists of a set of transactions and a  $\mathbb{3}$ . header. A  $\mathbb{3}$ . header contains the  $\odot$ . of the previous  $\mathbb{3}$ . and the roots of three Merkle trees.

Having a  $\mathbb{3}$ . formed and written, the  $\mathbb{3}$ .  $\odot$ . is recorded in a third-party trusted ledger.  $\mathbb{3}$ - can be also complemented with

signatures of extra validators in the system, that confirm the correctness of the chain and transformations.

## J. Merkle tree

The computation of the Merkle tree for transaction identifiers is similar to the algorithm described in RFC6962[5] section 2.1.2. SHA3-256[4] (FIPS-202) is used as a  $\mathcal{H}$  function. The last node is duplicated on levels with an odd number of vertices.

## VIII. CONCLUSION

The hybrid system of  $\check{M}$ imeses meets the specified technical requirements. User trust stems from the infeasibility of changing chain history that has been anchored in a third-party ledger. The described custom model of transactions that allows parallel processing, dynamic size, and time period of a  $\mathcal{Z}$ , provides sufficient throughput that meets the requirements for a planetary system of asset exchange.


